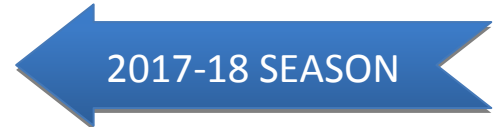


# Pomerelle Mountain Season Pass

- Age 13 & up = **\$349** + 20.94 tax = **\$369.94** (after 11/1/17 = \$450)
- Age 7 to 12 = **\$249** + 14.94 tax = **\$263.94** (after 11/1/17 = \$275)
- Age 6 & under are complementary when accompanied by a parent season pass.
- Child must be 12 or 6 years old through **Jan. 1, 2018**

## SEASON PASS CONTRACT

As the owner of a **Pomerelle Mountain Resort** season pass, you are entitled to the convenience of lift access without having to wait in line to purchase a lift ticket. To make the system work, it is imperative that all pass holders follow these simple rules and agree, in writing, to be bound by the policies and conditions on this contract. **It is the season pass holder's responsibility to learn and abide by these rules.**

1. **YOUR SEASON PASS MUST BE DISPLAYED IN FULL VIEW IT ALL TIMES.** Any MISCONDUCT (the use of intoxicating liquor or drugs, abusive language, reckless skiing/boarding or abusive lift usage, etc.) can result in revocation of this pass without refund.
2. In issuing this season pass, Pomerelle Mountain Resort makes no guarantee as to the opening date, number of days or nights of operation or of lifts and trails in operation. Pomerelle Mountain Resort makes no warranty as to the quality of the season. There will be no refund on the purchase price of a season pass for a marginal season or for failure of ski lift operation. **The buyer of a season pass assumes all risks of a marginal snow year.**
3. **SEASON PASSES ARE NON-TRANSFERABLE and NON-REFUNDABLE.** Your season pass may be used only by the person whose name and picture appear on the pass. Misuse of pass such as transfer to other person will result in revocation of the pass, without refund.

4. If your pass is lost or stolen, report it to the Pomerelle Ticket Office. Your original pass will be voided and there will be a **\$50.00 replacement charge** to reissue another pass. If you find your original pass, it must be returned to Pomerelle ticket office. If you arrive at Pomerelle without your season pass a regular lift ticket will need to be purchased. Complimentary lift tickets **will not** be issued.

5. The purchaser/user of this pass, in accordance with the Idaho Skier's/Snowboarder's Responsibility Act, Idaho Code Title 6-1106, understands that the sport of Skiing/Snowboarding involves risks of serious injury or death. Skier/snowboarder accepts and assumes the inherent risks, including but not limited to changing weather conditions, bare spots, variations in the snow, ice, and terrain along with bumps, stumps, trees, brush, rocks, forest growth and other natural vegetation, snowmaking equipment, grooming equipment, lift towers and other natural and/or man-made obstructions. Pomerelle is not responsible for accidents or injuries sustained by a skier/snowboarder using our facilities or caused by other skiers/snowboarders. Pomerelle is not responsible for accidents or injuries incurred to and from the parking area or entering/exiting any Pomerelle facility. **The user realizes that falls and collisions do occur and that serious injury or death may result and, therefore, assumes the burden of being in control at all times.**

WE ENFORCE THE NSAA SKIERS AND SNOWBOARDERS RESPONSIBILITY CODE, WHICH READS:

- **Always stay in control, and be able to stop or avoid other people or objects.**
- **People ahead of you have the right of way. It is your responsibility to avoid them.**
- **You must not stop where you obstruct a trail or are not visible from above.**
- **Whenever starting downhill or merging into a trail, look uphill and yield to others.**
- **Always use devices to help prevent runaway equipment.**
- **Observe all posted signs and warnings. Keep off closed trails and out of closed areas.**
- **Prior to using any lift, you must have the knowledge and ability to load and unload safely.**

**Violations of the NSAA Skier and Snowboarder Responsibility Code may result in the cancellation of a season pass.**

In consideration for each and every ride on any ski lift device, the user of this pass hereby RELEASES and HOLDS HARMLESS Pomerelle Mountain Resort and its agents and employees from any and all claims and liabilities arising out of or in connection with the use of the season pass including, but not limited to, skiing or snowboarding activities.

This season pass is revocable under the laws of Idaho and is revocable at the sole discretion of Pomerelle Mountain Resort. Violations of any federal, state, or local law while on Pomerelle Mountain Resort permitted area will result in season pass cancellation without refund. The licensee agrees that he/she does not and shall not claim at any time any interest or estate of any kind or extent whatsoever in Pomerelle Mountain Resort or its premises by virtue of this license or use hereunder. Duration of this contract is for the winter season for which it was purchased.

On behalf of myself and all others named on this season pass contract, I hereby RELEASE Andrwood Inc./Pomerelle Mountain Resort, management and employees, from any and all liability for damage or injury to me and all others named on this season pass contract. I accept the full responsibility for any and all such damage or injury of any kind, which may result directly or indirectly from the use of this pass from any skiing/snowboarding or other activities at Pomerelle Mountain Resort.
